b) To note public comments about parish highways priorities.

'Question: If you had a magic wand for road, pavement and footpath problems ... what's the first thing you'd fix in Alvington?'

- Pedestrian crossing and more street lights on the main road.
- Maybe street lights [so we can] see the pavement.
- "Hidden entrance" sign towards bottom of Swan Hill (we offered highways to pay for one/put one up and were refused for some bizarre nonsensical reason!) and reminders that it is 30 all the way down and up the other side - the 30 sign at the top of the hill looks like it just applies to those turning off left onto Knapp Lane. Double yellow lines on the hill and bus stop.
- Traffic calming on garlands road, a few people drive way too fast.
- Speeding on Garlands Road and Clanna Road.
- Better drainage on Clanna from the globe to Garlands Road.
- Sort the flood water problems out on Clanna Road and A48, footpaths in Garlands Road with speed bumps, pedestrian crossing and speed camera working.

- Main road so dark when walking up at night.
- The wreck of an old corner shop in Church Lane opposite the Globe. What an eyesore.
